NOTICE TO OUR CUSTOMERS

Clarification of Tipping Fees at the Indian River County Landfill



Since 1995, the Indian River County (IRC) Solid Waste Disposal District (SWDD) has established by resolution certain fees for the disposal of materials at the Indian River County Landfill. These rates remain as is; however, we are issuing this notice to clarify how fees are charged by our scalehouse staff to provide an equal and fair methodology.

The use of **GAR (Garbage)** code is restricted to only those companies that have a franchise agreement and are authorized by Indian River County SWDD and or a municipality to haul garbage. Specifically, this code is used only for **Waste Management** (*Unincorporated IRC, City of Fellsmere and the City of Sebastian*), **Waste Pro** (*Town of Orchid*), and **Treasure Coast Refuse/Republic Services** (*Indian River Shores and the IRC Customer Convenience Centers*), In addition, this code is used for both the **Indian River County School District** and the **City of Vero Beach** as they haul their own garbage. There are no exceptions to this policy. **Garbage codes are reserved for garbage ONLY** and **does not incur a disposal fee** as these are covered by both the residential and commercial solid waste assessment program.

Residential and Business customers may **self-haul** their personal garbage from their residence or their offices under the **GAR (Garbage)** code which also does not **incur a disposal fee** as this is covered by both the residential and commercial solid waste assessment program. *The hiring of a subcontractor is not considered "self-hauling"*.

Construction and Demolition (**C&D**) Debris is handled in two ways.

- 1) **Waste Management** and **residential customers** bringing their own construction materials are charged under the **C&D code or \$30/ton**. *This price does not include a franchise fee.*
- 2) Any other company or contractor bringing a container/dumpster, regardless of size into the landfill, the construction material are charged under the **WCD code or \$31.80/ton**. This includes all cleanout/junk-out companies. All companies must have a non-exclusive C&D franchise application on file and shall be issued a decal. *This price includes a franchise fee.*

Anyone that brings in garbage mixed with construction material regardless of the size of the container or company is charged under the **GCH code or \$32.50/ton**. This also applies to any by-product material that comes from **Indian River Recyclers, Inc.**

For verified clean dirt (**DIR**) and/or clean concrete (**CCD**), a charge of **\$3.00/ton** is applied.

All other codes are as applicable in the attached SWDD Rates and Fees.
